**INVITATION TO BID FOR THE PROCUREMENT OF VARIOUS DRUGS
AND MEDICINES OF BJMPRO-1
FOR THE 2ND QUARTER 2019**

1. The *Bureau of Jail Management and Penology Regional Office 1 (BJMPRO-1)* through the *National Expenditure Program (NEP) FY 2019 and DBM Circular Letter No.2018-8, dated 30, July 2018* intends to apply the sum of *Five Million Five Hundred Nine Thousand Two Hundred Eighteen Pesos and Seventy Five Centavos (P5,509,218.75)* Only being the Approved Budget for the Contract (ABC) to payments under the contract for the *Procurement of Various Drugs and Medicines of BJMPRO-1 for the 2nd Quarter 2019 with ITB# 2018-11-39*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bureau of Jail Management and Penology Regional Office 1* now invites bids for the procurement of Various Drugs and Medicines (please refer to the attached item list). Delivery of the Goods is required *within last week of March 2019*. Bidders should have completed, within *Two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from *Bureau of Jail Management and Penology Regional office 1, Logistics Division* and inspect the Bidding Documents at the address given below during office hours at *8:00 am to 5:00 pm*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *November 13, 2018-December 9, 2018 at 8 am to 5 pm and December 10, 2018 at 8 am to 10 am* from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Six Thousand Pesos (Php 6,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The **BJMPRO-I** will hold a *Pre-Bid Conference on November 26, 2018 at 10:00 o'clock in the morning at BJMPRO-1 Camp Florendo, Parian, San Fernando City, La Union*, which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat at the address below on or before *December 10, 2018 at 10:00 a.m.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
7. Bid opening shall be *on December 10, 2018 at 10:00 o'clock in the morning at BJMPRO-1 Multi-Purpose Hall, Camp Florendo, Parian, San Fernando City, La Union*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The **BJMPRO-I** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
