**INVITATION TO BID FOR THE PROCUREMENT OF VARIOUS
REHABILITATION SUPPLIES OF PDL OF BJMPRO-I
FOR THE 1ST QUARTER 2019**

1. The **Bureau of Jail Management and Penology Regional Office I (BJMRO-I)**, through the **DBM Circular Letter No. 2019-1 dated January 3, 2019**, intends to apply the sum of **One Million Two Hundred Twelve Thousand Pesos (P1,212,000.00)** only being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of Various Rehabilitation Supplies of PDL of BJMPRO-I for the 1st Quarter 2019 with ITB# 2019-02-05**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Bureau of Jail Management and Penology Regional Office I** now invites bids for the procurement of Various Rehabilitation Supplies (please refer to the attached item list). Delivery of the Goods is required within **Ten (10) Calendar Days upon issuance of Notice to Proceed**. Bidders should have completed, within **Two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from the **Head of Secretariat, Bureau of Jail Management and Penology Regional office 1, Logistics Division** and inspect the Bidding Documents at the address given below during office hours at **8:00 am to 5:00 pm**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 23, 2019 to March 17, 2019 at 8 am to 5 pm and March 18, 2019 at 8 am to 10 AM** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **BJMPRO-I** will hold a **Pre-Bid Conference on March 4, 2019 at 10:00 o'clock in the morning at BJMPRO-1 Camp Florendo, Parian, San Fernando City, La Union,** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **March 18, 2019 at 10:00 a.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. Bid opening shall be **on March 18, 2019 at 10:00 o'clock in the morning at BJMPRO-1 Multi-Purpose Hall, Camp Florendo, Parian, San Fernando City, La Union.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
9. The **BJMPRO-I** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
10. The BJMPRO-I reserves the right not to award the contract without any incurring liability if the fund/allotment for the said program/project/activity have been withheld or reduced through no fault of its own.
