The Pre-Bid Conference for the above projects held at BJMPRO-I, Multi-Purpose Hall, Camp Florendo, Parian, San Fernando City, La Union was called to order at **10:00 A.M.** on **December 4, 2019** by JSSUPT FLORANTE D NISPEROS, the BAC Chairperson.

1. Business Matters:

To discuss, clarify and explain, among other things, the eligibility requirements and the technical and financial components of the contract to be bid including questions and clarifications raised by prospective bidders.
